NOTIFICATION OF THE ADDENDUM TO THE ENVIRONMENTAL AUTHORISATION IN TERMS OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT 107 OF 1998) ("NEMA") AND THE ENVIRONMENTAL IMPACT ASSESSMENT REGULATIONS (2014, AS AMENDED):

In accordance with Regulation 4(2) of the Environmental Impact Assessment (EIA) Regulations, 2014 (as amended) we hereby notify you of the **addendum to the environmental authorisation that has been granted in terms of NEMA** as issued by the Department of Environmental Affairs and Development Planning (DEA&DP) in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) on the 10th November 2023.

The Environmental Authorisation is amended as set out below:

1. The deletion of the words "The development must be implemented in accordance with the layout developed by Robert Silke and Partners (dated 24 February 2023) Drawing number 202203 SKE 200 Rev 16 (Annexure 2)" wherever they may appear in Section B, Section E and Annexure 3 of the Environmental Authorisation, and the insertion of the following words in their stead:

"The development must be implemented in accordance with the layout developed by Robert Silke and Partners (dated 21 July 2023) Drawing number 202203 SKE 200 Rev 21 (Annexure 2)."

The authorisation outlines the reasons for the decision (refer to section B), the conditions of authorisation (refer to Section C) and the appeal process (refer to Section D).

APPEALS (ALSO DESCRIBED UNDER SECTION D OF THE ATTACHED ADDENDUM):

In order to comply with condition 1, all Interested and Affected Parties (I&APs) must be notified of the outcome of the decision, reasons for the decision (section B) and date of issue of decision.

We draw your attention to the fact that an appeal may be lodged against the decision in terms of the National Appeals Regulations, 2014 (as amended). Should you intend to appeal the

authorisation, an appeal must be submitted to the appeal administrator within **20 (twenty) days** from the date of this notification.

An appeal **must** be lodged in accordance with Regulation 4 of the National Appeal Regulation, 2014 (as amended) by means of the methods prescribed below:
